

In these roles, she built legal services capacity and led projects to expand access to health care, strengthening the ability of organizations to carry out their missions. As a member of NCMLP's Advisory Council she was part of a team that oversaw its transition to become a federally-funded technical assistance hub for health centers.



Sara Huffman

Managing Attorney Medical-Legal Partnership for Seniors Sara Huffman, JD, is the Managing Attorney of the Medical-Legal Partnership for Seniors (MLPS) clinic at UC Hastings College of the Law. The MLPS clinic partners with UCSF and the San Francisco VA Medical Center to provide free legal services to older adults in the areas of income and health care benefits, housing, legal planning for incapacity, and consumer issues. Sara handles her own clients and supervises staff attorneys and clinical students. She also serves on a multi-disciplinary consultation panel for VA system patients with highly complex medical/social needs and regularly provides health law related trainings to medical providers and community organizations. Sara founded the Veterans Project MLP partnership with the San Francisco VA Medical Center at MLPS in 2015 through an Equal Justice Works Fellowship.

Her current research focuses on health system-community partnerships, specifically measuring health and economic outcomes associated with medical-legal partnerships (MLPs). During her pediatric hospital medicine fellowship at Children's National Hospital, Dr. Nerlinger led efforts to develop evaluation standards for medical-legal partnerships. She is currently overseeing the creation, implementation, and evaluation of the first pediatric-focused medical-legal partnership in the state of Delaware.

She managed a caseload of 30-plus patient-families, representing clients primarily in the areas of special education, housing conditions, public benefits, and access to healthcare.

MLPs embed lawyers as members of the health care team, creating:

- Healthier patients
- Stronger health center workforce
- Improved health equity

Legal Assistance

to address patients' social needs & help the health center workforce operate at "top of license"

Training

to build knowledge, capacity, & skills that strengthen the health center workforce's response to SDOH

Clinic-Level Changes

that leverage legal expertise to shape clinical practices to address many patients' needs at once

Policy Change Strategies

that advance healthy regulatory, administrative, & legislative policy solutions for whole communities

Unable to take time at work to manage their condition	YES / NO
