OVERVIEW OF GEORGIA LEGAL SERVICES PROGRAM (GLSP)

- GLSP is a Legal Services Corporation Grantee Program.
- GLSP provides civil legal services to low-income people and individuals over 60 years of age in 154 counties in Georgia.
- GLSP was established in 1971, by the Younger Lawyers Division of the State Bar of Georgia.
- GLSP has 10 offices located in Georgia in its service area.



ATRIUM NAVICENT MEDICAL-LEGAL PARTNERSHIP

- Established in 2016
- Atrium Navicent Medical Center is a partner of GLSP
- Funded by foundation initially
- Now a line item in hospital funding budget
- Cases focused on different aspects of law including probate, public benefits, wills, housing, family law and education
- Located in Metropolitan area/4th largest city in Georgia





MCKINNEY MEDICAL CENTER - MEDICAL-LEGAL PARTNERSHIP

- MLP was established in 2022
- McKinney Health Center (est. in 1995) is our FQHC partner
- Discretionary funding initially
- Now part of the budget
- IHELP cases served model
- Located in a rural area/very rural
- 13,000 people
- 17% of population lacks health insurance
- 24% of the residents fall below the poverty line







TEN PRACTICAL TIPS TO CONSIDER WHEN PLANNING TO ESTABLISH A MLP

Identify an Appropriate Model – Health Center or Hospital.



TP2

Identify Key Players/Contacts to work with.





Identify the designation of a **defined patient population to be served**, with low-income and otherwise vulnerable populations being the most common.



National Center for Medical Degal Partnership

Develop a **strategy to screen patients for legal needs** that cannot be easily addressed by social workers or case managers.



Defined staffing arrangements should be agreed to, which typically include some dedicated healthcare staffing and 1 or 2 full-time lawyers (and in some cases), additional pro bono assistance from lawyers in private practice.)





A **formal agreement** that outlines the partnership's goals, respective responsibilities, and patient privacy protections should be developed.



Decide the staffing arrangement - A **"lawyer in residence" at the health care setting** (i.e., on-site legal services) for a defined amount of time every week, which enables attorneys to respond quickly to both patients and clinicians.



Training of health care staff members by MLP lawyers to help health clinicians recognize when legal interventions may be advisable.



An arrangement for **information sharing between partners** (some partnerships negotiate fully developed agreements that allow data to flow across organizations, either through parallel systems or directly within protected areas of the health organization's electronic record.)



Long-term funding should be discussed and prioritized.





Hospital MLP Model



- Partnered with Atrium Health Navicent
- Shared goal to support low-income health care patients in navigating legal challenges that create barriers to achieving better health.
- 100% funded by our medical partner.





Demographics

- Population of 465,901
- 66.9% urban, 33.1% rural
- 17.6% of the total area population living below the federal poverty level.
- 24.0% of children ages 0-17 are living below the federal poverty level.





Social Determinants of Health



- **11.3%** of the population age 25 and older **do not have a high school education**.
- 31.1% of population reports that they sometimes, usually, or always worry about having enough money to pay rent or mortgage within the past year.
- **16.3%** have lived in **unhealthy or unsafe housing conditions** within the past year.
- **13.4% went without electricity, water, or heating** in their home within the past year.
- **35%** of the community residents are **food insecure and have low food access**.





By the Numbers

- Received over **1,000** referrals during our first 7 years.
- Opened 689 cases representing 542 different patient-clients.
- Primary Case Types
 - Power of Attorney documents
 - Medicaid
 - Other public benefits
 - Kinship care
 - Family law





Motivations for Referrals

- Shorten length of stay
- Reduce readmissions
- Obtain a payor source
- Assist palliative patients
- Address current community issues







- Elderly patient received an emergency discharge from nursing home after altercation with another resident.
- Lived at the hospital for over a year while medical team figured out patient's needs and applied for Medicaid Waiver Program.
- Patient was denied Medicaid Waiver Program and MLP attorney was brought in to appeal denial.
- Financial benefit to medical partner and to patient were significant.



On-Location Office Space

- The McKinney Medical Center (MMC) gives us a dedicated office space – and signage at the center in Waycross.
- We are hopeful to soon have a similar dedicated space for our work done at the Folkston center.







Referrals & Help with Intake

With the **permission** of the clients they see, the McKinney Medical Center staff and doctors refer their patients to us whenever they sense there is a legal issue affecting that patient.

The McKinney Medical Center staff utilizes **uniform referral and confidentiality documents** that make pre-screening and thus intake easier.







Referrals & Help with Intake

MMC educates "Sliding Scale Fee" patients • lacksquareon benefits such as Medicaid, Medicare Peach State for kids etc., **assists** as needed in filling such applications, if benefits are denied then patients are **referred** to Georgia Legal services.



- MMC has an Affordable Care Act (ACA) navigator, and he **coordinates** outreach efforts in conjunction with GLSP attorneys.
- MMC staff refer a **wide** variety of clients who do not have access to income or have pending applications for benefits to our program.

Patients of McKinney Medical Center & The Community at Large

- New or current patients of the Mckinney Medical Center locations.
- Citizens of Ware and the surrounding rural counties such as Charlton, Camden, Bacon, and Brantley county.
- We find that a fair amount of our walk-ins know about us from word of mouth or advertisements.
 - Ex. the MMC publishes a running ad in the Waycross Journal Herald and in the Charlton County Herald.

Free Legal Services in Civil Cases

- Free representation, but there may be limited instances where the patient must pay for fees.
- We do NOT handle:
 - Criminal cases
 - Cases where the patient wants to sue another party for money
 - Cases where the patient already has an attorney



Legal Issues We Regularly See

- Domestic Violence Related Divorces and TPOs
- Estate Planning Issues (Power of Attorney and Wills)
- Securing and Maintaining Public Benefits
- Housing Issues and Dispossessory
- Consumer Issues and Elder Manipulation
- Medical Insurance Issues

What is a health center?

- Are community-based and serve more than 30 million people, about 90% of whom have incomes less than 200% of the federal poverty level.
- Provide access to medical, dental, behavioral, and other health care services.
- Provide care for all, with special initiatives for people experiencing homelessness, agricultural workers, and residents of public housing.
- A public or nonprofit entity can become a HRSA-supported health center by applying for Health Center Program funding or receiving designation as a Health Center Program look-alike. HRSA's Bureau of Primary Health Care (BPHC) oversees the
