

LEAD SAFE HOUSING FOR KIDS ACT OF 2017 (S. 1845/H.R. 6252) ENDORSEMENTS

The Centers for Disease Control and Prevention consistently cautions that no level of lead exposure is safe and children require a wide margin of safety. Lead poisoning causes irreversible, life-long brain damage, disability, and extreme costs to society. Under current law, children in the majority of federally assisted housing programs must develop lead poisoning before any meaningful lead hazard inspection is required. The bi-partisan Lead Safe Housing for Kids Act protects the four million American children in federally assisted housing from exposure to lead hazards.
